**Terms & Conditions of Tender :-**

1. Application along with following necessary documents for obtaining permission to participate in the Tender is to be submitted in the office of the undersigned on or before 05.07.2018 up to 3.00 pm.
2. Last date of permission for issuance of Tender Documents:-List of eligible applicants/construction firms permitted to purchase Tender documents will be displayed on the concerned office Notice board on 07.07.2018.
3. Last date of purchase of Tender document: - Up to 3.00 pm. On 09.07.2018 against payment of Rs 2000.00 only in cash (non-refundable/nonadjustable).
4. Last date of receipt of Tender Document: -Tender documents to be submitted in the Tender Box kept in the office of the Board of Trustee, Dakshineswar Kali Temple & Debottar Estate Up to 3.00 pm. on 12.07.2018
5. Date of Opening of Tender: - Tender documents will be opened by the Trustee or his authorised representatives in his chamber on the same date i.e. 12.07.2018 at 5.30pm in presence of intending tenderers or their authorised representatives.

1. Name & style of the contractor. In case of consortium, certificates and agreements between the firms should be given stating clearly the status.
2. In case of Partnership firms an authenticated document of partnership deed of memorandum , articles of association and details of Board of Directors as applicable
3. Address of register office, address of office in Kolkata, if any, with Telephone nos. & Fax numbers etc.
4. A list of works of comparable magnitude and the nature of works successfully completed by the construction firms in the last three years including location , cost, schedule, time of completion along with performance certificates indicating that these works were completed within contractual period and reason of delay, if any,(Copies of Work orders and related completion certificates etc. to be attached)
5. The list of present commitment & percentage of works completed so far and expected date of completion.
6. Technical reference from at least three employers should be given to whom reference may be made.
7. An undertaking declaring that the firm was not blacklisted at the past under any Govt. /Semi Govt. or any other organisation
8. List of construction equipment available for the proposed works.
9. List experienced Technical personal with their qualification, experience and age.
10. Extent of availability of Design Know how.
11. Xerox copy of PAN card, P.Tax, valid Income tax Return (for last three years), valid 15 digit Goods & services Tax payer identification number (GSTIN) under GST act 2017& latest valid Trade license , valid Provident Fund& ESI registration certificates.
12. Solvency certificates issued by the Banker of the Firm/ Company.
13. Financial capacity & credit facilities available to the firm / Company as certified their Banker.(Banker Certificates in original or duly attested to be submitted).
14. Unemployed Engineers' Co-operative Society shall have to submit all document in respect of their Society viz. Registration certificate, Audited Balance sheet for the last 3 (three) years along with their application.
15. Any other relevant information considered necessary to justify eligibility of the applicant.

**Other salient point to be noted by the Tenderer:-**

1. Earnest money @ 2 % (two percent) of the estimated amount or as mentioned in the NIT, should accompany the tender documents in the shape of Bank Draft / Pay Order drawn on any Nationalised Bank payable at per at Kolkata and to be drawn in favour of “ **Trustee, Dakshineswar Kali Temple and Debottar Estate, Temple Development Fund**”. **No Cash or Cheque will be accepted as Earnest money.**
2. Successful Tenderer are to execute formal agreement in prescribed form along with other documents in 4(four) sets which will be available from the concerned Office on payment of Rs. 2000.00 (Rupees Two thousand) only per set. Successful Tenderer are also to deposit balance amount of @ 2% of the tendered amount, if any, (without any sealing limit) as initial security deposit. The sum deposited in the above process for the successful tenderer will form part of security deposit and balance @ 8% will be deducted from each on going bill.
3. The earnest money of the unsuccessful tenderer shall be refunded within 30 (thirty) days from the date of finalisation of the tender on application to this regards.
4. Amount of Security deposit will be @ 10 % (Ten percent) of the amount of contract without any upper ceiling
